

4.2 Main Steps for ICT System Development / Maintenance

- 4.2.1 ICT will receive directives for development or maintenance of a system.
- 4.2.2 ICT unit will gather the requirements from users for the project to establish the process flow.
- 4.2.3 ICT unit will register the project in GISP as required by e-Government Authority to get approval.
- 4.2.4 After approval from e-GA, the development/ maintenance of the system will begin.
- 4.2.5 Once the development of the system is done the system will be tested by ICT Unit for verification of requirements.
- 4.2.6 Then the system will be tested by users to get their feedback.
- 4.2.7 There after the system will be subjected to security vulnerability check process
- 4.2.8 After pass from the security check, system will be launched for use
- 4.2.9 Finally, the ICT unit shall prepare the Report, user manuals and user guides for system use.
